Affected Facility	Columbia River Carbonates – Marine Terminal 1901 Dike Road, Woodland, WA 98674	
Description of Facility	Columbia River Carbonates operates a marine terminal designed to import bulk calcium carbonate via barge and stockpile material onsite. Columbia River Carbonates will use trucks to transship stored material from the terminal to existing processing facilities in Woodland Washington.	
Source Designation	<u>Minor</u> . The facility is a stationary source subject to review under SWCAA 400-110. Facility emissions will be less than 100 tpy of any single criteria pollutant, less than 10 tpy of any single hazardous air pollutant, and less than 25 tpy of any combination of hazardous air pollutants.	
Purpose of Application	SWCAA has received a permit application for an increase in previously approved throughput limits for the above described facility. The application has not yet been reviewed to determine if it is administratively complete. The SWCAA permit writer identified below will be reviewing the application to make a determination of completeness and, if necessary, make a request for additional information. A copy of the application will be available to the public when the application is determined to be complete.
