Affected Facility	North Pacific Paper Company, LLC 3001 Industrial Way, Longview, WA 98632	
Description of Facility	North Pacific Paper operates a thermomechanical pulp mill, recycled pulp mill, and paper mill at the above facility.	
Source Designation	<p><u>Title V.</u> The facility is a stationary source subject to the Operating Permit Program contained in Chapter 173-401 WAC. Facility emissions are greater than 100 tpy of a single criteria pollutant, greater than 10 tpy of any single hazardous air pollutant, and/or greater than 25 tpy of any combination of hazardous air pollutants.</p> <p><u>Major/PSD.</u> The facility is a stationary source subject to review under WAC 173-400-141. Facility emissions are greater than the applicable criteria pollutant emission threshold defined in SWCAA 400-030(61) "major stationary source". The applicable emission threshold for this facility is 250 tpy of any single criteria pollutant.</p>	
Purpose of Application	SWCAA has received a permit application for approval of a voluntary limit on hydrogen peroxide consumption at the above described facility. The application has not yet been reviewed to determine if it is administratively complete. The SWCAA permit writer identified below will be reviewing the application to make a determination of completeness and, if necessary, make a request for additional information. A copy of the application will be available to the public when the application is determined to be complete.
