Affected Facility	Joseph T. Ryerson and Son Inc.	
Description of Facility	Processor and distributor of metal products. Operations at the facility will include general metal cutting, oxyacetylene cutting, and plasma/laser cutting. The facility cuts stainless steel, carbon steel, and aluminum. Metal cutting processes are controlled using dust collectors. There will also be four natural gas fired heaters used for industrial heating.	
Source Designation	<u>Minor</u> The facility is a stationary source subject to review under SWCAA 400-110. Facility emissions will be less than 100 tpy of any single criteria pollutant, less than 10 tpy of any single hazardous air pollutant, and less than 25 tpy of any combination of hazardous air pollutants.	
Purpose of Application	SWCAA has received a permit application for installation and operation of metal cutting equipment and natural gas-fired equipment at the above described facility. The application has not yet been reviewed to determine if it is administratively complete. The SWCAA permit writer identified below will be reviewing the application to make a determination of completeness and, if necessary, make a request for additional information. A copy of the application will be available to the public when the application is determined to be complete.
