Affected Facility	Braun Northwest, Inc. 150 North Star Drive, Chehalis, WA 98532	
Description of Facility	Braun Northwest builds emergency vehicles such as ambulances, SWAT vehicles and prison transports. The facility operates four vehicle preparation stations and three spray coating booths in support of production activities.	
Source Designation	<u>Minor.</u> The facility is a stationary source subject to review under SWCAA 400-110. Facility emissions are less than 100 tpy of any single criteria pollutant, less than 10 tpy of any single hazardous air pollutant, and less than 25 tpy of any combination of hazardous air pollutants.	
Purpose of Application	SWCAA has received a permit application for an increase in facility-wide emission limits at the above described facility. The application has not yet been reviewed to determine if it is administratively complete. The SWCAA permit writer identified below will be reviewing the application to make a determination of completeness and, if necessary, make a request for additional information. A copy of the application will be available to the public when the application is determined to be complete.
