Installation of a newly built animal crematory (Thermtec G-30-P) at 122 Bear Prairie Rd, Washougal, WA 98671. This unit will primarily be utilized as an animal crematory.

The unit is approximately 16' long x 8'4" wide x 27' 10" high from the floor to the top of the stack

The unit will be installed onto a concrete slab and will be powered by 220v electric and fueled by LPG.

The installation site will be onto a flat concrete slab at 122 Bear Prairie Rd Washougal, WA 98671. The primary area at the location is primarily flat and surrounding areas are gently sloped.

Preparation for concrete will involve excavation of an area approximately 16'x 30' x 6". Gravel from off site will be brought in as fill to provide a stable base for under the concrete. There will also be trenching for underground utility lines (propane and electrical power). The trenching will be approximately 50'.

f. Could erosion occur as a result of clearing, construction, or use? If so, generally describe.
Areas excavated for construction will have gravel added prior to concrete being poured. The added gravel will stabilize and prevent erosion from occurring.

About what percent of the site will be covered with impervious surfaces after project construction (for example, asphalt or buildings)?
Concrete will be poured on a 16' x 30' area.

Proposed measures to reduce or control erosion, or other impacts to the earth, if any:
Gravel will be added to reduce or control erosion. Exposed soil will be reseeded and covered with chopped / blown straw or hay.

Emissions to the air during construction will be minimal and from a tractor during construction. During operation following completion, the Thermtec G-30-P will be fired by propane and will be cremating animal remains which will lead to emissions. Approximate quantities of emissions are unknown at this time.

The Thermtec G-30-P has an after burner that will pre-heat to 1600 degrees F prior to the primary burner igniting. The afterburner will reduce and control emissions and impacts to the air.


