Affected Facility	Lakeside – Pelletizing Plant (Asphalt) 500 Tennant Way, Longview, WA 98623	
Description of Facility	The proposed facility manufactures pelletized asphalt binder from reclaimed asphalt shingle feedstock using two portable pelletizers operating in parallel. The reclaimed feedstock will be manufacturer's new reject shingles or asbestos free tear-off shingles.	
Source Designation	<u>Minor</u> . The facility is a stationary source subject to review under SWCAA 400-110. Facility emissions will be less than 100 tpy of any single criteria pollutant, less than 10 tpy of any single hazardous air pollutant, and less than 25 tpy of any combination of hazardous air pollutants.	
Purpose of Application	SWCAA has received a permit application for installation of portable processing equipment in support of pelletized asphalt manufacturing operations at the above described facility. The application has not yet been reviewed to determine if it is administratively complete. The SWCAA permit writer identified below will be reviewing the application to make a determination of completeness and, if necessary, make a request for additional information. A copy of the application will be available to the public when the application is determined to be complete.
