Description of Facility	The proposed facility is a metal fabrication facility that will manufacture saw blades for use in the lumber industry. Facility operations will include cleaning, laser cutting, welding, milling/grinding, abrasive blasting, and heat treating of various metal parts.		
Source Designation	<u>Natural Minor.</u> The facility is a stationary source subject to review under SWCAA 400-110. Facility emissions are expected to be less than 100 tpy of any single criteria pollutant, less than 10 tpy of any single hazardous air pollutant, and less than 25 tpy of any combination of hazardous air pollutants.		
Purpose of Application	SWCAA has received a permit application for installation of a new saw blade manufacturing facility at the above described location. The application has not yet been reviewed to determine if it is administratively complete. The SWCAA permit writer identified below will be reviewing the application to make a determination of completeness and, if necessary, make a request for additional information. A copy of the application will be available to the public when the application is determined to be complete.
