Final Regulatory Order for Voluntary Limit on Hydrogen Peroxide Consumption

Dear Mr. Anneberg:

A final determination to issue Air Discharge Permit 25-3680 (ADP 25-3680) has been completed for Air Discharge Permit (ADP) Application CO-1107 pursuant to Section 400-091 of the General Regulations for Air Pollution Sources of the Southwest Clean Air Agency (SWCAA). Public notice for ADP Application CO-1107 was published in the permit section of SWCAA's internet website on January 10, 2025. SWCAA did not receive a request for a public comment period in response to the public notice and has concluded that significant public interest does not exist for this determination. Therefore, a public comment period was not provided for this permitting action. An electronic copy of ADP 25-3680 is available for public review in the permit section of SWCAA's internet website (http://www.swcleanair.gov/permits/adpfinal.asp). An original copy is enclosed for your files.

This Regulatory Order may be appealed directly to the Pollution Control Hearings Board (PCHB) within 30 days of receipt as provided in RCW 43.21B.

ORDER TO ESTABLISH VOLUNTARY PROCESS LIMIT

LONGVIEW, WASHINGTON)	REGULATORY ORDER

- 1. RCW 70A.15.2040(3) authorizes the Southwest Clean Air Agency ("SWCAA") to issue such orders as may be 'necessary to effectuate the purpose of the Washington Clean Air Act and to enforce the same by all appropriate administrative and judicial proceedings.
- 2. SWCAA 400-091 authorizes SWCAA to set a voluntary limit on the potential to emit, process parameters or throughputs of any source or stationary source, at the request of the owner or operator of the source. This section is federally enforceable and is an approved element of the Washington State Implementation Plan.
- 3. The purpose of this Regulatory Order ("Order") is to establish a legally enforceable process parameter limit on the consumption of hydrogen peroxide bleach in the thermo-mechanical pulping ("TMP") process at North Pacific Paper Company, LLC ("NORPAC") in Longview, WA. The terms and conditions of this Order are based on an application filed by NORPAC on January 9, 2025.
- 4. Beginning on the Effective Date of this Order, the consumption of hydrogen peroxide bleach in the TMP section of NORPAC's Longview mill must not exceed 64,059 dry tons during any period of 12 consecutive calendar months. For the purposes of this requirement, the amount of hydrogen peroxide received will be presumed to be the same as the amount of hydrogen peroxide consumed.

- 5. Beginning on the Effective Date of this Order, NORPAC must monitor and record the monthly mass of hydrogen peroxide bleach in dry tons received by NORPAC, measured at the meter that records hydrogen peroxide bleach deliveries to NORPAC at the point of receipt. NORPAC must include that data in the monthly air report, along with a rolling 12-month figure that aggregates the monthly data from the most recent 12-month period.
- 6. This Order shall take effect on the first day of the second month that follows the date of issuance of the Order. In the event of an appeal of the Order, its provisions shall be stayed until final resolution of any such appeal.
