

The proposed rule revisions will revise selected sections of SWCAA 400 to update federal regulation adoptions, revise 70.94 RCW references to 70A.15 RCW, update definitions, incorporate new alternative opacity standards for boilers, revise noticing and registration requirements for portable sources, prohibition of cyclonic burn barrels, remove outdated startup/shutdown provisions, adopt permit extension procedures, establish new emission inventory submittal deadline for gasoline stations, create new rule sections regarding credible evidence and agency information requests, clarify review procedure for Title V fee review, and incorporate minor editorial retitling and renumbering.
